COLLABORATING, ASSESSING and LINKING

The WCSI Criminal Justice Liaison Program was developed to help prevent individuals with behavioral health needs from entering or moving further into the criminal justice system. This can be accomplished by intercepting these individuals at the law enforcement and/or magisterial levels.

The Criminal Justice Liaison Program provides:

- ◆ *Linkage to Crisis Services*
- ◆ *Assessment*
- ◆ *Forensic Case Management*
- ◆ *Support in Court Hearings*
- ◆ *Diversion and Referrals*
- ◆ *Monitoring/Linking to Community Services*
- ◆ *Education on Available County Resources*

After initial assessment by the Criminal Justice Liaison, WCSI Intake Specialists can perform a detailed assessment to determine the appropriate level of case management for the individual. The individual will then be referred to treatment programs that are tailored to his/her specific needs.

THE CRIMINAL JUSTICE LIAISON PROGRAM WILL SERVE WESTMORELAND COUNTY RESIDENTS WITH:

- Behavioral health concerns
- Co-occurring issues (substance abuse and mental illness)
- Any type of insurance

A CRIMINAL JUSTICE

- ◆ BEHAVIORAL HEALTH PROVIDERS

Criminal Justice Liaisons are assigned to specific magisterial districts in Westmoreland County, as well as the police departments that serve those districts.
